This year's craft fair will be in a partially shaded, paved parking lot at BURNEY SPORTING GOODS 37427 STATE HWY 299E BURNEY, CA 96013. The booth size will be 12X12 (no electricity available, your own QUIET generator permitted). Vendors are responsible for their own tables, chairs, pop-ups, ice chests, water, trash removal, etc. The cost of each booth space will be \$50.00. We accept check or cash as payment. Non-profit organizations are exempt from paying for their booth space but may be required to prove they are a non-profit.

Exciting news this year! We listened to your concerns last year and we will be offering WI-FI this year for vendors ONLY. It will be an extra \$5.00 to use the internet. **IT IS ONLY INTENDED FOR VENDORS AND NOT TO BE GIVEN TO THE PUBLIC.**

FOOD VENDORS ARE REQUIRED TO BRING THEIR OWN TRASH CANS AND BE EXPECTED TO EMPTY THEM INTO THE ONSITE DUMPSTER PROVIDED AS WELL AS ANY DEBRIS FROM THEIR SPACE.

ALL VENDORS MUST REMAIN IN THEIR SPACE FROM 9AM-4PM.

SALES OR POSSESSION OF ALCOHOL, WEAPONS, ILLEGAL SUBSTANCES OR FIREWORKS IS STRICTLY FORBIDDEN!!! Any violators will be prosecuted.

ABSOLUTELY NO REFUNDS AFTER JUNE 19th, 2026.

Upon receipt of your application and payment, your CA resale license, with the correct location, and food handlers permits will be checked (example of correct resale permit attached on the back). After your information has been confirmed and it is after the cutoff date of June 19th, 2026, we will send out a map with your booth location marked. There will also be instructions regarding set up times, loading areas, parking, etc.
